
Eureka PM<sub>2.5</sub> Trends










Weaverville PM<sub>2.5</sub> Trends









**Crescent City PM<sub>2.5</sub> Trends**

#### SUMMARY:

On June 17, 2021, President Joe Biden signed the Juneteenth National Independence Day Act, establishing June 19 as a federal holiday. June 19 holds special meaning for the African American community known as Juneteenth. Juneteenth is the oldest known celebration commemorating the ending of slavery in the United States, celebrating that day in history, June 19, 1865. President Abraham Lincoln signed the Emancipation Proclamation on January 1, 1863, declaring the slaves in Confederate territory free, paving the way for the passing of the 13th Amendment, which formally abolished slavery in the United States of America. However, after the signing of the Emancipation Proclamation, it took almost two and a half years, to June 19, 1865, for the declaration to reach authorities and Black/African American individuals in the South and Southwestern United States.

In Humboldt County, the Board of Supervisors on June 15, 2021 adopted a proclamation declaring June 19 as Juneteenth Day in Humboldt County to bring awareness and to celebrate this historical day of freedom and county offices were closed in observance.

The District Personnel Manual has a schedule of Board-approved holidays listed in Chapter II – Employee Benefits and Compensation, Section II – Holidays:

All regular employees shall be entitled to the following paid holidays:

- 1. New Year's Day (January 1)
- 2. Martin Luther King Day (3rd Monday in January)
- 3. Lincoln's Birthday (February 12)
- 4. Washington's Birthday (3rd Monday in February)

Memorial Day (Last Monday in May)
 Independence Day (Fourth of July)
 Labor Day (First Monday in September)
 Columbus Day (Second Monday in October)
 Veteran's Day (November 11)
 Thanksgiving Day (Fourth Thursday in November)
 Friday after Thanksgiving
 Christmas Eve (December 24)
 Christmas Day (December 25)

District Staff recommends the Board consider the above information and discuss any actions it would like to take in regards to District observance of the new federal Juneteenth holiday. Any changes to the District Personnel Manual would require a Board action.

#### SUMMARY:

The District's FY2021-22 Budget was approved on May 20, 2021, however there are three budget amendments that are now needed as relevant information was not known at that time:

a) Purchase of District vehicle -

The District's current vehicle used for purposes of air monitoring was scheduled to be replaced. The District had received Subvention Funding from the State that was earmarked for the replacement and had tentative arrangements to purchase a Ford Transit Connect Cargo Van from a local Ford dealer at fleet/government pricing. However, the District was unable to finalize the financial purchase transaction in the last fiscal year due the fact that Ford was significantly cutting its North American vehicle production due to an ongoing shortage of semiconductor chips impacting the global automotive industry. To accommodate, the unspent funding for the vehicle in last year's budget (\$35,000) simply needs to be moved into this current year's budget. Since these funds will be coming from Reserve, the overall bottom line of the budget will reflect a \$35,000 negative balance.

b) State Prescribed Fire Program Support Grant funding -

The Board adopted Resolution 2019-2 which authorized APCO to enter into Grant Agreement(s) with the State to accept any associated funding for the State Prescribed Fire Program Support Grant. The main use of the funds has been to cover allowable costs of its smoke management program (applicable burn permits, smoke management plans, monitoring, and outreach) consistent with SB 901 and SB 1260. The District has been submitting grant disbursement requests to the State on a quarterly basis for reimbursement. However, the state needed to provide the

remainder of the unspent grant funds (\$50,753) for the first/initial grant agreement term by June 30, 2021 as advance payment, rather than through disbursement requests. These funds received should be included in this year's current budget.

c) Additional AB617 Community Air Protection Grant funding -

On May 16, 2019, the District Governing Board approved Resolution 2019-3 which authorized the APCO to sign CARB Community Air Protection Grant Agreement(s) and to accept any associated grant funding. In late May 2021, the District was again approved for a grant by CARB under CARB's FY 2020-21 AB617 Community Air Protection Program. The District was awarded \$14,169 consistent with the funding allocation approved by CAPCOA, under a Grant Agreement that starts June 1, 2021 and ends June 30, 2023. The grant agreement was signed May 27, 2021 and funds are to be received in the District's current FY 2021-22. The current District budget was approved prior to receiving this additional Grant Agreement funding, and therefore needs to be amended to reflect these funds.

In order to spend the funds outlined above, the Board will need to approve and accept the funding into the current fiscal year budget as follows:

The following information is provided as a summary of items of interest to the Board and District. Staff solicits and appreciates any feedback concerning these items or other items of interest from the Board.

#### 1. Wildfire Smoke Update

So far for the 2021 Wildfire season, there have primarily been large smoke impacts east of our jurisdiction in Siskiyou and Shasta Counties from the Lava, Salt, and Tennant Fires.

The District in coordination with the Public Health Departments of Humboldt, Del Norte, Trinity Counties and regional Tribal Health Departments, provides Air Quality Smoke Advisories as needed during wildfire events. This year, the District will issue a single combined Air Quality (AQ) Smoke Advisory notification document during wildfire events (see attached), rather than the separate documents (e.g., the PSA, Advisory, Alert) done in prior years. This comprehensive AQ Smoke Advisory will indicate the Air Quality Index (AQI) levels of concern (Hazardous, Unhealthy, Moderate, etc.) for communities for which there is acceptable forecast information. During wildfire events, AQ Smoke Advisories will be updated as conditions change.

The District maintains an email distribution list for sending AQ Smoke Advisory notifications. AQ Smoke Advisories are sent to media sources, schools and the general public. The District, California Air Resources Board (CARB), and the EPA highly recommend using the EPA's Fire & Smoke Map (<u>https://fire.airnow.gov</u>) for air quality smoke impacts and current AQI information. Although there are alternative websites with similar information, this website provides the best information for viewing smoke maps, deployed PM2.5 wildfire monitors, and corrected sensor information. The District website also provides links to the latest and most accurate information available on wildfire smoke impacts and actions to protect yourself from smoke.

The District also provides a Wildfire Smoke Guidance and Recommended Activity Guide for Schools During Wildfires for schools when there is wildfire smoke, which has been sent to the schools and is available on the District website. This guide is based upon the California Department of Education's (CDE's) air quality guidance template for schools, which provides recommendations for schools and others responsible for children during a wildfire smoke and other air quality event(s). The guidance provides health recommendations for schools, coaches, and event coordinators regarding student exposure to wildfire smoke.

#### 2. <u>Yurok Project Application for EPA Grant: Environmental Justice Collaborative</u> <u>Problem Solving</u>

The District was pleased to provide a letter of support to the EPA's Environmental Justice Collaborative Problem Solving (EJCPS) - Cooperative Agreement Program on behalf of the Yurok Tribe and Karuk Tribe. The Tribes recently submitted a project application for the "Climate Resiliency in Yurok and Karuk Ancestral Territories – Creating a Data Collection Plan for Prescribed and Cultural Burns to Combat Catastrophic Wildfires and to Support and Strengthen Cultural Resources and Traditional Food Systems." The District will also be contributing within an Air Quality Working Group as a project collaborator.

#### 3. <u>Prescribed Burning in California</u>

Data is now available for prescribed burning occurring in California air districts. Attached are two charts indicating the amount of prescribed burning that occurred for the FY 2020-21 period by acreage and by number of prescribed burns. The District remains as one of the main jurisdictions that approve the most prescribed burning (acreage and number of burns) in California.

#### 4. 2022 Health Benefit Costs

CalPERS will be changing its rating methodology for group medical plans in 2022 (see attached). In 2022, CalPERS medical plans will be rated on value, not on risk. This means more credibility will be given to the actuarial value of a health plan than to the claims cost per employee enrolled in the plan. This change is forecast to yield rate changes in 2022 in excess of more than 20% for some CalPERS plans.

CalPERS will be publishing preliminary 2022 rate changes, and rate and plan offerings will be finalized in July with a limited time period to consider options. The District currently provides PERS Choice PPO which will be eliminated, and either PERS Select (Gold) or PERS Care (Platinum) will need to be chosen as replacement options. District staff will bring this item forth as an agenda item when more information is known.

#### 5. Update on PG&E Regular Variance Activity

On February 3, 2020, the District's Hearing Board approved the Regular Variance for PG&E as proposed, and the Regular Variance Order 2020-01 was subsequently signed on February 28, 2020.

The Regular Variance was to provide relief from permit conditions and permit emission limitations (until June 30, 2020) to allow the HBGS to conduct the emission (source testing) and other operational testing necessary to confirm their readiness to operate in an island mode or as a black start unit to serve area load. In addition to the short-term emission testing performed last December 2019, PG&E finished operational testing of Ammonia Injection Load Point Determinations (i.e. fine tuning the emission control SCR system) for loads less than 50% in April. The variance also allowed for island operational testing to determine the actual ability of the plant to achieve real-world operation similar to PSPS conditions, which PG&E completed on May 9, 2020.

On July 10, 2020, the Hearing Board issued Hearing Order No. 2020-02 for a Regular Variance to PG&E (see attached Order and Staff Report). The regular variance granted to PG&E provided relief from permit conditions and permit emission limitations for a period of up to one year, while allowing the HBGS to potentially operate in island mode during upcoming emergencies such as Public Safety Power Shutdown (PSPS) events and to conduct engine tuning at loads less than 50%. HBGS will also be submitting an application to modify its Title V Operating Permit. The proposed variance will be in effect for a period of up to one year or until a modified Operating Permit and other applicable modified licensing is effective, whichever date is sooner.

On June 18, 2021, PG&E submitted a variance application request to extend the expiration date of the Hearing Order by one year to allow the HBGS to continue to operate in low load and in Island Mode during PSPS and other events. The District is currently making arrangements for a Variance Hearing Board meeting on July 26, 2021 that will consider extending the Variance Oder.

Press release issued: June X, 2021 Advisory updated as conditions change

Several wildfires continue to impact the air district region of Humboldt, Del Norte, and Trinity Counties. Smoke impact conditions may reach unhealthy conditions in the communities as indicated below. Air quality monitors and the current Air Quality Index (AQI) for communities should be viewed at <a href="https://fire.airnow.gov">https://fire.airnow.gov</a>. USFS Air Resource Advisors (ARAs) may be assigned to certain fires impacting our area and may also provide daily Smoke Outlook Forecasts these fires (https://wildlandfiresmoke.net/outlooks/).

#### ALERT – Hazardous Conditions (AQI 301 and higher) over the next 24 hours:

- Hoopa Hazardous
- Willow Creek Hazardous
- Residents should plan to continue to take measures to protect their health, such as staying indoors as much as possible to avoid exposure to smoke

#### Smoke Impact Summary

The ARA on the Red Salmon Fire indicates that wind and smoke patterns are expected to be SW today. The day will start off with mostly good air quality near Hoopa Valley and Willow Creek, but concentrations of smoke will increase late in the day. Depending on how much smoke is produced, it may travel to Eureka.

The Slater and Devil fires in Eastern Del Norte and along the Oregon border will be affected by strong NE winds today and tonight before becoming easterly on Monday. Smoke transport should generally be to the SW/W. Northern coastal areas should continue to see Good air quality; however, offshore flow could potentially bring smoke to the coast if smoke production increases. A strong ridge of high pressure will be affecting this area, and we will see increased temperatures and decreasing wind speeds by midweek.

The ARA on the August Complex Fire also forecasts NE winds continue into Monday, pushing smoke to the south and southwest, affecting southern Humboldt. Hot, dry, and windy conditions will lead to an increase in smoke production and allow smoke from other fires to move into the region. Due to the elevated winds across the ridges, smoke may not settle into valleys as it typically does. However by early this upcoming week, strong high pressure will create a stagnant pattern resulting in worsening air quality for Southern Humboldt and Mendocino.

Particulate Matter (PM2.5) monitors are located in Crescent City, Gasquet, Eureka, Weaverville, Hoopa, Weitchpec, Willow Creek, Klamath, Trinity Center, Bridgeville, and Garberville.

As with all wildfires, ash fallout is possible depending on fire activity and proximity to the fires. #### Health Information & Actions To Protect Yourself From Smoke Impacts

Concentrations of smoke may vary depending upon location, weather, and distance from the fire. Smoke from wildfires and structure fires contain harmful chemicals that can affect your health. Smoke can cause eye and throat irritation, coughing, and difficulty breathing. People who are at greatest risk of experiencing symptoms due to smoke include: those with respiratory disease (such as asthma), those with heart disease, young children, and older adults.

These sensitive populations should stay indoors and avoid prolonged activity. All others should limit prolonged or heavy activity and time spent outdoors. Even healthy adults can be affected by smoke. Seek medical help if you have symptoms that worsen or become severe.

Follow these general precautions to protect your health during a smoke event:

- Minimize or stop outdoor activities, especially exercise.
- Stay indoors with windows and doors closed as much as possible.
- Do not run fans that bring smoky outdoor air inside examples include swamp coolers, whole-house fans, and fresh air ventilation systems.
- Run your air-conditioner only if it does not bring smoke in from the outdoors. Change the standard air conditioner filter to a medium or high efficiency filter. If available, use the "re-circulate" or "recycle" setting on the unit.
- Do not smoke, fry food, or do other things that will create indoor air pollution.

Consider leaving the area until smoke conditions improve if you have repeated coughing, shortness of breath, difficulty breathing, wheezing, chest tightness or pain, palpitations, nausea, unusual fatigue, lightheadedness.

The North Coast Unified Air Quality Management District ("North Coast AQMD") is a regional environmental regulatory agency that is a Special District of the State of California whose jurisdiction is Humboldt, Del Norte, and Trinity counties in Northern California. The North Coast AQMD is pleased to provide this letter of support and to demonstrate our commitment to the "*Climate Resiliency in Yurok and Karuk Ancestral Territories – Creating a Data Collection Plan for Prescribed and Cultural Burns to Combat Catastrophic Wildfires and to Support and Strengthen Cultural Resources and Traditional Food Systems"* project application, submitted by the Yurok Tribe.

We believe that the unique opportunity to have experts from various Tribal Governments, Federal agencies, State agencies, local agencies, non-profits, and academia collaborate to create a Data Collection Plan will lead to greater resources and support for the communities within Yurok and Karuk ancestral territory to conduct restorative and healing cultural and prescribed burns. The resulting environmental impacts, most notably improved air quality due to the decrease in frequency and intensity of catastrophic wildfires and increased access to local traditional foods and cultural resources, will benefit everyone in the region and beyond. While our formal role in the project is still under development, we can commit to at least one staff person attending the Quarterly Project Meetings and Working Group Meetings related to air quality. We may be able to have more than one staff member participate in the project, in order to better represent the scope of our work in prescription burns and smoke management, ongoing monitoring, and data information.





#### Preparing for 2022 Health Benefits Costs

With CalPERS changing its rating methodology for group medical plans in 2022, CalPERS members may be looking for alternative providers such as SDRMA's Health Benefits Program.

According to Alliant Insurance Services, in 2022, CalPERS medical plans will be rated on value, not on risk. This means more credibility will be given to the actuarial value of a health plan than to the claims cost per employee enrolled in the plan. This change is forecast to yield rate changes in 2022 in excess of more than 20% for some CalPERS plans.

In a public meeting on November 17, 2020, CalPERS staff forecast plan and rate changes for 2022. Listed below are the key changes described at that CalPERS Pension and Health Benefits Committee meeting:

- The PERS Choice PPO will be eliminated. Enrollees who wish to retain CalPERS PPO coverage in 2022 may move . to PERS Care or PERS Select.
- PERS Select will be re-named PERS Gold, and PERS Care will be re-named PERS Platinum.
- 2022 rates for PERS Select (Gold) are forecast to increase more than 20%, while for PERS Care (Platinum) rates are forecast to decrease by slightly more than 10%.
- CalPERS has suggested that benefits for PERS Select (Gold) will be reduced in 2023 to further differentiate the plan from PERS Care (Platinum). This change will be discussed further and is expected to be finalized by the CalPERS Pension and Health Benefits Committee in Fall 2021.
- 2022 rates for the CalPERS broad network HMOs Anthem Traditional and Blue Shield Access+ will change • slightly. Rates for the United Healthcare Alliance HMO are forecast to increase more than 8%.
- In November 2020, it was estimated that Kaiser's 2022 rates might be as much as 3% higher than their 2021 rates.
- Some health plans will expand their service areas and other new models of narrow network plans will be • offered, mostly in Southern California.

On June 15<sup>th</sup>, CalPERS published preliminary 2022 rate changes. Rates and plan offerings will be finalized in mid-July, with a limited time period to consider options.

In contrast to the CalPERS 2022 rate forecast, SDRMA's Medical Benefits Program anticipates a 3.3% rate increase in 2022. Our Health Benefits Program includes medical, dental, vision, basic life and AD&D, short term disability, long term disability, and an employee assistance program.
